ORDER:

The Government of India had announced a new scheme "Skills Strengthening for Industrial Value Enhancement" (STRIVE) to be assisted by the World Bank, with the objective of improving the relevance and efficiency of skill training provided through Industrial Training Institutes and apprenticeships. The project emphasizes special focus on strengthening industry linkages in Industrial Training Institutes and apprenticeship ecosystem across India. The result area 4 deals with the improvement and broadening of Apprenticeship Training. This area involves the strengthening of apprenticeship training on the basis of industrial infrastructure and the cluster of industries is included as a stakeholder in this project.

2. In the letter first read above, the Government of India, Ministry of Skill Development and Entrepreneurship, had sanctioned for release of funds of Rs.40.00 lakh (Rupees Forty lakh only) as 40% advance on signing of tripartite agreement under the component Result Area-4 (RA-4) (Improved and Broadened Apprenticeship Training) of World Bank assisted project "STRIVE" to the Ambattur Industrial Estate Manufacturers Association (AIEMA) through State Directorate during the financial year 2019-2020.

3. Hence, in the letter second read above, Commissioner of Employment and Training has requested to transfer the amount of Rs.40.00 lakh released by Government of India towards incurring the expenditure under the component, Result Area-4, Improved and Broadened Apprenticeship Training through Public Finance Management System (PFMS), to the State Project Implementation Unit (SPIU) SVEETS Society of the Training Wing of Commissionerate of Employment and Training.

4. The Government after careful examination accept the proposal of Commissioner of Employment and Training and approve Ambattur Industrial Estate Manufacturers Association (AIEMA) as Industrial Cluster and sanction a sum of Rs.40 lakh (Rupees forty lakh only) for incurring the expenditure under the component Improved and Broadened Apprenticeship Training (Result Area-4) in the STRIVE project and also issue the following orders:-

i. State Apprenticeship Monitoring Cell shall monitor the performance of Industry Cluster Ambattur Industrial Estate Manufacturers Association (AIEMA) in accordance with the provision and procedure prescribed in the operations manual of STRIVE scheme.

ii. Administrative and financial powers shall be delegated to the Industry Cluster Ambattur Industrial Estate Manufacturers Association (AIEMA) as per the condition stipulated in Operations Manual.

iii. The Commissioner of Employment and Training is permitted to draw and disburse the released amount to AIEMA through SVEETS society for carrying out the project activities as per the Tripartite Agreement and STRIVE scheme guidelines as prescribed by Government of India.

5. The expenditure sanctioned in para 4 above shall be debited under the following Head of Account:-

The Commissioner of Employment and Training is directed to include this item of expenditure while sending the budget proposal for RE/FMA 2019-2020 and also send necessary draft explanatory note for inclusion of this expenditure in the supplementary Estimates 2019-2020 to Government in Finance (L&E/B.G-1) Department at the appropriate time without fail.
